Admissions Requirements

- A bachelor's degree (or equivalent) from a regionally accredited university
- A "principles of accounting" course in which the student earned a C or better or equivalent. William & Mary offers a free Financial Accounting Fundamentals tutorial. This tutorial offers a quick pathway for applicants without an accounting background to fulfill this requirement. - A current [resume or CV](#) with employment history
- A completed [online application](#), including:

 - Two professional recommendations
 - Optional personal statement
- Official academic transcripts from all institutions from which a bachelor's or graduate degree was earned
- Proof of English language proficiency for non-U.S. citizens. Applicants must have a TOEFL score of at least 100 if internet-based, 250 if computer-based or 600 if paper-based, or an IELTS score of at least 7. Exemptions may be granted for applicants who have earned a degree from an accredited U.S. institution or lived and worked full-time in a predominantly English-speaking country for the past two years
- Application fee of \$100 (nonrefundable). The application fee may be waived for applications submitted by the priority deadline, active-duty military and veterans, W&M alumni, attendees of informational webinars, and at the discretion of the Admissions Office. Contact an admissions outreach advisor to discuss whether you qualify for a fee waiver
- Personal admission interview. Qualified applicants who have submitted and completed their application will be invited within five business days to schedule a personal admission interview. Interviews can be conducted via video conference or by telephone

*Students might need to complete up to eight credits of prerequisite courses.

[†]Students who are required to complete the prerequisite courses can graduate in as few as 18 months.

**There is no residency requirement for the Online MAcc program, but students have the option to participate in non-credit-bearing residency weekends.



Curriculum

The Online MAcc program welcomes students with educational and professional backgrounds in business, accounting and a diverse range of other fields. In cases where they will be useful, we offer prerequisite courses in a fast-track format, so that all students are equipped to start the Online MAcc curriculum on an equal footing.

Our 32-credit-hour curriculum can be broken down in the following ways:

Four prerequisite courses, which can be waived for qualified applicants

- BUAD 509A: Financial Reporting
- BUAD 509B: Strategic Cost Management
- BUAD 509C: Individual Income Taxes – Rules and Planning
- BUAD 509D: Audit and Assurance

Eight core courses

- BUAD 5709: Financial Reporting Standards and Analysis (4 Credits)
- BUAD 5719: Accounting Analytics and Information Systems (4 Credits)
- BUAD 5729: Advanced Audit and Audit Research (4 Credits)
- BUAD 5739: Financial Statement Analysis and Valuation (4 Credits)
- BUAD 5749: Driving Organizational Performance (4 Credits)
- BUAD 5759: Advanced Federal Taxation (4 Credits)
- BUAD 5417: Advanced Corporate Finance (4 Credits)
- BUAD 5779: Accounting for Complex Business Transactions (4 Credits)

In addition, students have the option to attend residency weekends.
